OUR MEMBERS

Kindergarten Parents Victoria's members are predominately not for profit organisations that offer early childhood education programs and other children's services throughout Victoria. Members include volunteer committees of management, cluster managers, integrated services, schools, local governments and long day care centres. Other organisations subscribe to KPV because they value our expertise in matters such as industrial and workplace relations, governance, financial planning and occupational health and safety.

Members have told us they place a high level of importance on KPV lobbying the government on their behalf and highly value the support KPV provides for governance, finance and management issues and industrial advice. Particular appreciation is expressed for the telephone advisory service.

KPV continues to review 'what we do' and 'what we say' to ensure that we are a truly representative and responsive membership organisation.

MEMBER SUPPORTS

ADVICE AND TRAINING

KPV members value our telephone and email advisory service operated by our expert advisors. We assist members with a diverse range of issues involving committee governance, service management and operation, industrial relations, human resources, occupational health and safety (OHS) and wage rates.

KPV received over thirteen thousand calls and emails during the last financial year. KPV also made thousands of out-going calls and emails and made many site visits to members to assist in the resolution of complex situations.

Consultancy projects requested by members canvassed a broad range of areas, including: staff performance appraisals, governance audits, financial audits and reviews, training presentations, industrial advice and transition of businesses. This year saw continuing interest in professional development for staff and performance appraisals.

KPV conducted numerous training sessions across the state during 2010/11 on a range of topics, in particular governance and management issues. Local councils and members hosted many of these sessions.

KPV hosted three seminars in 2010/11 which were all well attended and received positive feedback from participants. The seminar *Universal Access: one step at a time* in September 2010 included presentations on the evidentiary basis that supports Universal Access and practical workshops from three services that have planned and/or begun implementation of 15 hours of kindergarten programs.



ADVISORY

KPV prepared and presented a number of submissions to the State and Commonwealth Governments after consultation with our stakeholders, members and board. KPV is regularly asked by the media to comment on behalf of our members and our board in relation to early childhood matters. KPV's submissions to government can be found at www.kpv.org.au.

We were asked by the media to comment on many issues concerning our members and the sector including; kindergarten fees and childcare costs for families, major early childhood education and care policy reforms, government funding, new education programs and budget announcements.

KPV represents the voice of our members on a variety of community and government consultation groups and committees. KPV's President, board members and CEO, have represented our members in regular meetings with State and Federal Ministers, members of parliament and senior state and federal education officials.

KPV's Cluster Manager Reference Group, chaired by KPV board member Jo Geurts, is a regular consultative forum where cluster

manager members share information, discuss policy innovations and their implications and advise KPV on issues pertinent to the sector.

KPV represents the voice of our members on a variety of community and government consultation groups and committees.

The KPV Industrial Relations Reference Group, chaired by KPV board member Danny Pearson, includes cluster managers and independent kindergarten members. The IR Reference Group provides the KPV board and staff with informed opinion on the broad range of industrial and employment issues which affect KPV members and the early childhood sector generally.

KPV was the presenting partner of the 2011 Early Childhood Education Conference, Together we grow – achieving sustainable practices and a member of the organising committee for the 2010 Romp & Stomp event at the Melbourne Museum, a successful children's week event attracting over 2,000 preschool children and their families.

In October 2010 KPV, together with a number of other community services organisations, hosted a seminar *Are you prepared?*Due diligence for Community Sector Executive Management, which introduced executive staff to the new national OHS laws, the Model Work Health and Safety Act 2009 which will come into effect in all states and territories from January 2012.

The Managing staff and working together seminar in May 2011 was a seminar especially for sector employers featuring experts in the fields of staff management, recruitment, industrial relations and OHS with sessions tailored for cluster managers and independent committees of management.

KPV assists members with a diverse range of issues involving committee governance, service management and operation, industrial relations, human resources, occupational health and safety and wage rates.

KPV in partnership with Gowrie Victoria and an organising committee of early childhood services stakeholders presented the 2011 Early Childhood Education Conference, Together we grow – achieving sustainable practices on 3–4 June at Caulfield Racecourse. High profile international and Australian speakers explored the theme of sustainable practices in early childhood services, with over 800 early years' teachers and staff, volunteer committees, employers and parents.

RESOURCES

Governance Tips, Safe & Sound (OHS), Industrial and Wages Bulletins are KPV's regular specialist newsletters to help members understand and comply with a range of legislation, regulations, funding and other requirements for the day to day running and governance of a not for profit service.

During the year KPV has reviewed our flagship publications, which support committees of management and managers in the delivery of their programs, to reflect contemporary practice and policy reforms. KPV has updated the Early Childhood Management Manual, which is an essential tool for managers and committees of management and produced a new version of ModelWorks (V3) to reflect the program requirements under *Universal Access* and other policy reforms.

Preschool Matters our quarterly magazine, on-line E-newsletters and monthly member mail-outs continue to keep members informed of the latest developments in the sector. *E-news*, our on-line newsletter has over 3,000 subscribers.

For the 16th year running, the KPV's *Caring For Kids* raffle was a tremendous success. The 2011 raffle raised over \$120,000 for the early childhood sector, which is a substantial contribution to the education of our children.

FINANCIAL STATEMENTS

TREASURER'S REPORT

Summary

The financial statements presented with this report are for the year to 30 June 2011 and disclose an operating surplus of \$98,196 (2010 Deficit: \$116,626), a net asset position of \$745,486 (2010: \$647,290) and a net increase in cash flows of \$259,485 (2010: decrease of \$147,772).

Income Statement

The net surplus largely comprises income from KPV consultancies, grants, subscriptions and other related activities and a decrease in administration, operational and staff expenses.

Balance Sheet

KPV's balance sheet indicates that KPV has a solid net asset position with sufficient liquid assets to meet all liabilities.

Cash Flow

Our cash flows from operations and investing activities disclose an increase to our cash position of \$259,485 for the year.

Going Forward

KPV recognised that it could not continue to incur operational losses and as a result it was very pleasing to report a small surplus this year. KPV Board and management focussed on minimising expenditure while generating additional sources of income. For the coming year, KPV will continue to focus on achieving a surplus and current budget projections support this aim.

AUDITOR'S REPORT

I have audited the accompanying summarised financial report of Kindergarten Parents Victoria Inc., comprising the balance sheet as at 30 June 2011 and income statement for the year then ended, which was derived from the financial report of Kindergarten Parents Victoria Inc. for the year ended 30 June 2011.

The Responsibility of the Board for the Financial Report

The Board of the Association are responsible for the preparation and fair presentation of the financial report. The procedures selected depend on the auditor's judgement, including the assessment of the risks of material misstatement of the financial report, whether due to fraud or error. In making those risk assessments, the auditor considers

internal control relevant to the Association's preparation and fair presentation of the financial report in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Association's internal controls. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by the Board, as well as evaluating the overall presentation of the financial report.

The financial report has been prepared for distribution to the members for the purpose of fulfilling the Board's financial reporting requirements under the Associations Incorporation Act (Vic) 1981. I disclaim any assumption of responsibility for any reliance on this report or on the financial report to which it relates to any person other than the members, or for any purpose other than that for which it was prepared.

I believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for my audit opinion.

In conducting the audit, I have complied with the independence requirements of the Australian professional accounting bodies.
